Enrollment Agreement 2011-2012

ENROLLMENT: I/We agree to enroll my/our child, _____
into the Dryden Montessori School (DMS) for the 2011-2012 school year in the
following program. Full Day is 9am-3:30pm. Half Day is 9am-12pm

And subject to the following terms

BINDING AGREEMENT: I/We understand that:

- By signing this Enrollment Agreement, I/We are entering into a legally binding contract to pay the full amount of the annual tuition stated herein unless: 1.) DMS requests the child to withdraw. 2.) If parent requests the child to withdraw, they will continue to be responsible for the remainder of the tuition until a replacement can fill the spot. The only exception to the above term is withdrawal of the child due to a life-changing event such as loss of employment, death of supporting family member, or relocation. Under these circumstances, parents will be responsible for a minimum of 3 months tuition from the date of withdrawal or until such time that the spot is filled (whichever is sooner).
- DMS reserves the right to cancel a child’s enrollment if payments are not made by the due dates.
- Late payments are subject to a late charge of \$25 per month to cover added administrative costs. Payments are considered late 10 days after due date.
- In the event that DMS incurs expenses in connection with the enforcement of this contract and/or collection of moneys owed under this contract, I will be responsible for reimbursing DMS for such expenses incurred, including attorney’s fees and costs.

- Acceptance by DMS on one occasion of any late payment shall not be a waiver of its rights with respect to any other late payment.

TUITION: I/We agree to pay tuition in monthly installments due on the 15th of the month prior to attendance, beginning with _____ (Tuition for _____). Failure to make an installment payment within 30 days of its due date gives DMS the right to declare the entire unpaid balance of the annual tuition immediately due and payable.

DEPOSIT: I/We enclosed a deposit equal to one-month's tuition. The deposit is not refundable. This deposit will be applied against the tuition for the last month of the school year (June 2012) governed by this Enrollment Agreement. If it is mutually agreed that the child's enrollment should be cancelled, DMS will use this deposit as a 30-day notice of termination payment. DMS agrees to negotiate partial payments for this deposit if initial deposit and first month's tuition creates a hardship.
